Honoring Assata Shakur's Legacy

"On September 25th, 2025, we lost Assata Shakur, a revolutionary, writer, and fierce advocate for Black liberation. Her life was one of courage and defiance—standing against systemic oppression and inspiring generations to resist, to organize, and to imagine a freer world.

In her poem Affirmations, Assata wrote:

"And if I know anything at all,
It's that a wall is just a wall
And nothing more at all.
It can be broken down."

Assata's words continue to remind us that no matter how powerful the prison walls, no matter how oppressive the state, they can be dismantled. Her voice affirms life, truth, and the possibility of transformation, even in the darkest of times.

Assata also carried a deep and unwavering commitment to political prisoners. Speaking of Mumia Abu-Jamal, she once wrote:

"The first time I heard a tape of one of Mumia's radio broadcasts, it was the first time I fully understood why the United States government was so intent on putting him to death... We could not save Malcolm X, but we can save Mumia. We can save him, and we must save him. Because we love our brother, and we need our brother to help us fight for freedom. Free Mumia Abu-Jamal, free all political prisoners."

At Prison Radio, we carry this legacy forward every day by amplifying the voices of people inside prison walls, voices that expose injustice, demand humanity, and keep alive the fire of truth that Assata believed in.

Assata Shakur's life and words are proof that art, resistance, and testimony can move mountains, and tear down walls. Let us honor her by listening, amplifying, and acting." Source: Email.

Three Tactics From The Black Panthers' Anti-Autocracy Playbook

"The FBI drugged Fred Hampton, then shot him in the head while he slept. The next morning, Black Panthers served free breakfast to 50,000 children.

While the federal government was assassinating their leaders, the Panthers kept serving eggs, working to survive and organize while being systematically attacked by the U.S government's law enforcement and intelligence services.

By 1980, the Party was mostly finished, crushed by assassinations, frame-ups, and infiltration. But for a few crucial years, they proved something that matters for us today: even under lethal state repression, communities could coordinate their own survival and influence political machinations. Casey Goonan sentenced to nearly 20 years in federal prison

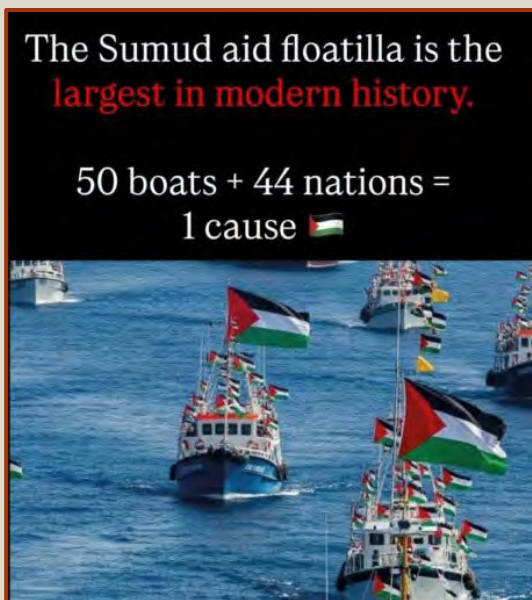


"Update 9/23/25 from the [Casey Goonan](#) Support Committee. Today at the federal building in downtown Oakland, dozens of friends, comrades and family gathered to support Casey at their sentencing hearing. Before a courtroom with pews full of supporters, both the US Attorney and Casey's legal team made their arguments before the judge in addition to Casey themselves addressing the court and reading a prepared statement. In alignment with the plea deal between the prosecution and the defense, the prosecution asked for a sentence of 188 months with an additional 15 years of close supervision afterwards that would include, among other restrictions, no possession of a computer or digital device without the approval of a parole officer, the installation of surveillance software on any device if possession was granted. The defense didn't contest the close supervision but proposed a sentence of 96 months..." For full article see:

Understanding solidarity with political prisoners

“Last week, I wrote to remind us all about our ability to do something to get in the way of the genocide machine. Today, I’m writing to you with updates from Palestine and around the world, along with some action items and resources.

On October 6, 2023, there were approximately 5,250 Palestinian prisoners being held in Israeli prisons. This was already a serious injustice; indigenous Palestinians are unjustly subjected to Israel’s system of colonial laws and policies which exist to imprison, eliminate, and erase them in order to build the state on top of their homeland. The occupier has no right to enforce its laws on the indigenous Palestinian people.

Today, the Palestinian Prisoners’ Club announced that the total number of *known* Palestinian prisoners has risen to 11,100. This includes 3,577 administrative detainees, who are held indefinitely and without charge, 2,662 detainees classified as “unlawful combatants”, and 400 children. I note these are the total number of *known* prisoners because it is not known how many Palestinians from Gaza have been abducted and continue to be held in Israeli army camps.

The number of Palestinian prisoners has doubled in less than two years while conditions inside of these centers have only continued to get worse. Prisoners released from occupation custody bear the marks of abuse and neglect on their often emaciated bodies; their words only elaborate on the horrors they have experienced. Palestinian prisoners report severe torture, regular beatings, a policy of starvation and denial of water, medical neglect and abuse, sexual abuse, inadequate clothing and sleeping arrangements, horrific cell conditions, and even a policy of applying electric shocks. Since 1967, 320 Palestinian political prisoners have died or been killed in Israeli jails. 76 of these political prisoners have been killed in less than two years. Recently, Tahani Abu Samhan, a 33 year old teacher from al-Zarnuq, near Nablus, gave birth to her son in Damon Prison. She was abducted and has been detained since June 2025, spending her last months of pregnancy under torturous conditions. She named her son Yahya. Today, he is the world’s youngest prisoner.

Baby Yahya is a reminder of the martyr Yousef al-Zaq, who was also born inside occupation prisons in 2008 during Israel’s detention of his mother, Fatima al-Zaq. They were liberated during a prisoner exchange in 2009, but Yousef was murdered at 17 when [Israeli forces struck his family’s home](#) with a drone equipped with a missile in Gaza City this July.

In other parts of the world, prisoners who have been imprisoned for their solidarity with Palestinians and against genocide also face punitive treatment. [T. Hoxha, a prisoner](#) held for her alleged participation in a Palestine Action raid on an Israeli weapons firm in Filton, England, is completing her 25th day of hunger strike following the prison’s politically-targeted abuses against her. Casey Goonan, a diabetic political prisoner in California, and their cellmate, have now joined Hoxha’s hunger strike in solidarity with her efforts to regain her job in prison and receive the mail that has been sent to her. While we read about the horrific conditions Israel imposes on Palestinian prisoners, support the [fundraisers of families in Gaza](#), and organize to make a just future in Palestine, we cannot forget about the most vulnerable in our own communities. You can read more about T. Hoxha’s case below, and take action to support her in receiving medical care and have her demands met by taking a few minutes to [carry out the actions detailed here](#). It shouldn’t take more than a few minutes.

Even as we continue to celebrate Elspeth’s life and manage our everyday lives without her, one of the questions many folks have been asking is how one can make a donation in Elspeth’s Memory, to carry on the work she held so dear. Though this was discussed and decided before the memorial service and announced at that time, there was so much else going on that little or no money was raised for the two causes that best reflect her life and politics. We’re sending this reminder note now, in hope and expectation that both of these worthy projects will get a chunk of support as we all remember our dear one.

As we know, Elspeth was generous with her donations to a wide variety of causes. Since the Puerto Rican people and their movements were especially near and dear to her, these two causes have been selected, as they will most directly benefit the activists that she knew best and their most pressing current work.

Luis Rosa Perez and the Puerto Rican former political prisoners were championed by Elspeth, both before and after their release. The group Occupied People's Forum (OPF) was formed several years ago, bringing together still-colonized resistance representatives from Puerto Rico and Palestine, Kurdistan/Rojava and Kashmir, Western Sahara and West Papua, Tibet and Ambazonia. Luis has been a leading part of OPF, along with a number of Puerto Rican friends and comrades; he has also continued to advocate for the rights of the Puerto Rican people through his work as a producer, director, and author. Currently, he and we are raising money to attend a rare in-person meeting of the OPF, to take place immediately following the International Peace Research Association's biennial conference being held entirely on Indigenous Māori land, in Aotearoa (New Zealand), from November 4-12, 2025.

Luis or whatever Puerto Rican representative attends the November meetings will be joined by leaders from the other movements – including key representatives directly from Palestine – to share strategies and bring back ideas and plans for our collective work forward. Resistance in Brooklyn (RnB) can accept contributions and pledges for this through checks, cash, and even credit cards.

Since 2015, the Health and Acupuncture for the People Project has been dedicated to offering an inspiring voluntary and self-managed health and wellness service to the Puerto Rican community. Close friends of Elspeth have been instrumental in their work. After Hurricane Irma and Maria and the recent earthquakes, this work has become vital to people's survival and well-being. Having a skilled and dedicated local group has allowed for almost-immediate services when official aid was (and is) slow to come. Their project is supported by donations exchanged by clinic participants, individual donations, and individual support from local community projects. "My experience with solitary confinement, as defined by the United Nations¹, began in early May of 2013. At that time i was confined in the Harris county jail. The day of my conviction and sentencing, to life without parole, i was subsequently housed in solitary at the 1200 Baker Street jail. i was placed there, purportedly, because of the length of my sentence, administrators deemed such a sentence to be traumatic enough for one to have an uncontrollable desire to harm themselves or others or attempt an escape. At the instance of one gavel slam, i went from being in a normal jail setting surrounded by a multitude of other prisoners, an arrangement i had been in for NEARLY two years without much incident, to the 'New Boogey-man' incapable of rational emotional expression. Political Prisoner Shine White: Interview with Shine White and One of his Supporters



"First if you would introduce yourself to our listening audience. Foremost, I take this opportunity to greet you all with a spirit of revolutionary love and rage. For those who don't know me, I am Komrade Shine White; I am a prisoner in the state of North Carolina. I've been imprisoned for 13 years now. 9 out of the 13 years has been spent in some form of solitary confinement, as a reprisal for my continued involvement in various efforts to expose and resist the conditions of racism, brutality and neglect that prisoners are subjected to, not only here in North Carolina but nationwide. I would like to point out to the listening audience that you mentioned the conditions of racism. You are white. So how is it that you are subjected to racism?"

Correct, I am white, which means that I should be devoted to taking an emphatic stand against the false ideology of white supremacy and racism in general. I believe that for poor whites to be liberated from class oppression and the suffering that comes with poverty, we must make common cause with the struggles of non-white peoples who have historically been victimized and exploited by a rich, white minority of capitalists. So yes, racism is something that I am constantly struggling against, as should all whites. In fact, I've been told by several of my overseers that I am worse than the Black prisoner. Not only am I a white Blood, but I am a white prisoner with "Black beliefs." "Black beliefs"! This reveals to me another aspect in the oppressor's way of thinking. The oppressor differentiates Black and white beliefs. To these racist-ass pigs, Black people's position in society should always be different from white people's position: like we are not of the same human race..." 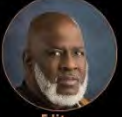

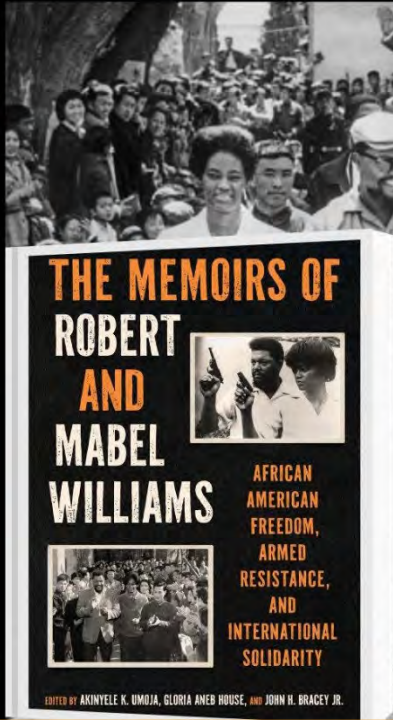


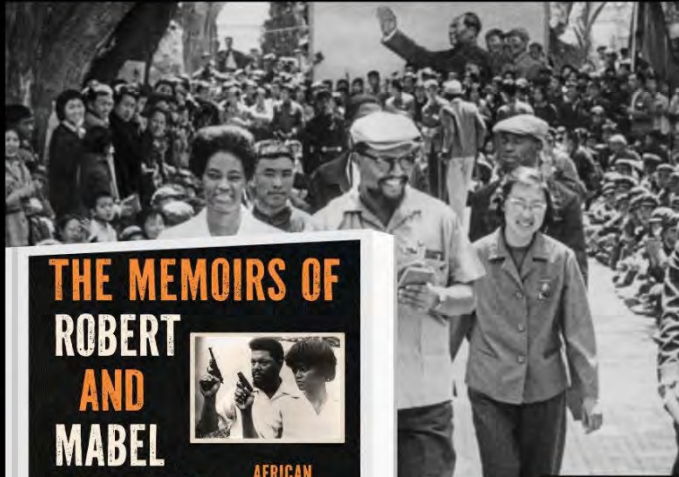

DC Anti-Criminalization Collective:

Statement on MPD's History of Violence against Black people and the killing of Jonathan Boruch

“On Tuesday September 16th, the Metropolitan Police Department killed another Black man, this time in Northwest DC. **His name was Jonathan Boruch**. Already, before the family has answers and before any true investigation has taken place, MPD has rolled out its well-developed narrative playbook. A

sergeant under investigation for misconduct stood before the cameras and spoke as if their “multiple investigations” were already complete, delivering a story crafted to shut down outrage, redirect questions, and ensure the public’s first instinct is not grief, but suspicion: *What did he do? He must have deserved it.* We refuse this manipulation. We know better.

Police killings are not accidents, mistakes, or isolated events. They are part of how policing is designed to function. This system is not broken, it was built this way. From its history in slave patrols to its present-day structure and culture, policing has always been rooted in control, domination, and violence. These killings are not the work of “bad apples.” That myth is dangerous because it hides the truth: police violence is systemic, not individual. The system cultivates, enables, and protects the officers who kill.

When police fire their weapons into our communities, it is gun violence. Just like any other shooting, police gunfire leaves families shattered and communities traumatized. But unlike other gun violence, police shootings are legitimized, justified, and excused by the very systems meant to protect the public. Officers are trained to escalate, to draw weapons, to issue threats, and to respond with deadly force at the first sign of resistance and then to call it “safety.” Police often manufacture the very conditions they later use to justify murder: escalating routine encounters with aggression, force, and weapons; dehumanizing Black people and marginalized communities as threats whose lives are worth less; creating fear and panic, then claiming that fear as justification for deadly force. This cycle is not an accident; it is standard operating procedure.

After a killing, police move swiftly to control the story. They present themselves as objective investigators while smearing the victim as criminal, dangerous, or unstable. They emphasize officer safety above all else. They speak as though killing is not only justified, but inevitable. The media amplifies this framing, highlighting a victim’s past or alleged behavior rather than the fact that another life was taken. Courts, unions, internal affairs, and political leaders reinforce it, ensuring that accountability is the rare exception rather than the rule. Society is taught to trust police, even as their violence piles up in our neighborhoods. That trust creates bias. People are quick to assume that if the police killed someone, they must have had a reason. For many, the alternative, admitting that police kill unjustly and with impunity, is too uncomfortable, because it challenges the foundation of a system people want to believe keeps them safe. Instead, the victim is blamed, their humanity erased. And here in D.C., this has been the daily reality for hundreds of thousands of Black people, immigrants, unhoused neighbors, and youth for generations. This history is not new, it is the present we are forced to live with.

We demand that Mayor Muriel Bowser and Chief Pamela Smith release all investigative reports and findings, including Force Investigation Team (FIT) reports. We demand the immediate firing of all officers involved in this killing. We demand that the Mayor, the Police Chief, and members of the D.C. Council demonstrate the ability of this city to govern itself without cowering to the forces that are stripping that ability away, no matter how much you conform, comply, or pacify. **Nothing less than full transparency and accountability is acceptable.**

While the District mourns the loss of another Black life at the hands of MPD, the D.C. Council voted to increase MPD officers’ salaries. This comes after a devastating budget cycle where the Council made deep cuts to medical, housing, homeless, and legal service funding – things that actually keep us safe. It is time for the District to invest in real safety that prioritizes people, not punishment.

All Black people in D.C. deserve, and have a human right to, safety in their communities from all forms of violence, whether it comes from the community or from the police. Both community violence and

police violence are leaving blood in our streets, and it must stop. We must be honest as community members: more police presence and more policing has not made us safer. It has only increased the likelihood of police abuse and murder.

To our fellow DC residents, we call on each other to ground ourselves deeply in the reality of this ongoing war on our community members — Black people, immigrants, unhoused community members, youth, and so many others. **We must refuse to act from a place of powerlessness.** We must publicly and continuously challenge the narratives police use to protect themselves and erase our people. We must remind the world that MPD has always been what it is, an institution of violence and control. Everyone can do something. We call on our neighbors to find their place: get connected to what is already happening, learn as much as you can, and use that knowledge and those skills to build collective power in this community. This will be a long-term fight, and it requires all of us to plan, act, and stay together.

The DC Anti-Criminalization Collective is a group of anti-fascists that organize to shrink DC's carceral system (MPD, DC Jail, and the courts) through political and popular education, council facing advocacy, and mass mobilization. This moment calls on all of us to deepen our commitment to building a DC where safety means housing, healthcare, schools, Black joy, and freedom — not cages, not police, and not more violence.

Major Tillery, 75 Years Old, Imprisoned for Over 43 Years, has had Cardiac, Liver, & Circulatory Problems. He now has Pain, Swelling, and Discoloration of his right leg, indicating a DVT, (Deep Vein Thrombosis) and risk of a Pulmonary Embolism.

In the PA DOC medical diagnosis and treatment of prisoners is under the control of a private company, Wellpath. At SCI Chester, Dr. Paul Little is in charge. Both Wellpath and Dr. Little are subjects of numerous federal lawsuits for failures to provide timely care, and practices leading to deaths of dozens of incarcerated individuals. The DOC has regulations that require "immediate completion of the diagnostic process and treatment when there is any clinical suspicion of a potentially serious or life-threatening illness." That is Major Tillery's situation. SCI Chester has stated he has "vascular insufficiency."

The DOC must act to have Major Tillery immediately transferred out of the prison clinic and to a hospital for a full –cardiac, vascular, pulmonary—workup and treatment, including the possibility of surgery.

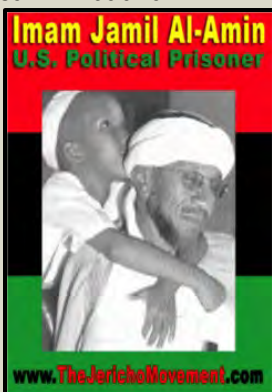

The island was put under virtual martial law, and eventually five men: Ismail Ali, Warren (Aziz) Ballantine, Meral (Malik) Smith, Raphael (Kwesi) Joseph, and Hanif Shabazz Bey were apprehended and then charged with the attack. All the men were known supporters of the Virgin Island independence movement. The five were charged after being subjected to vicious torture, in order to extract confessions. They were beaten, hung

from their feet and necks from trees, subject to electric shocks with "cattle prods", had plastic bags tied over their heads and had water forced up their noses by the "defenders of the law." The judge (Warren Young) overlooking the case prior to being placed on the federal bench worked as Rockefeller's private attorney and even handled legal matters for the Fountain Valley Golf Course. Eventually, the five went to trial in what became known as the "Fountain Valley" murder trial. This was an obvious Kangaroo Court and a mockery of any sense of a fair trial. On August 13, 1973, each of the five men convicted and sentenced to eight (8) consecutive life terms. Today, Warren (Aziz) Ballantine, Meral (Malik) Smith, and Hanif Shabazz Bey are all confined in federal prisons. Ismail Ali was liberated to Cuba via an airplane hijacking in 1984. Raphael (Kwesi) Joseph was granted a pardon by the V.I. governor in 1992. Six years later Kwesi was mysteriously found dead of

poison-laced drug overdose, after it was said that he was about to reveal evidence that would have exonerated at least one or more defendants.” <https://www.thejerichomovement.com/profile/malik-smith>

“On December 9, 1981 Mumia Abu-Jamal, a journalist and former Black Panther, was arrested for the murder of a white Philadelphia police officer Daniel Faulkner. He was convicted and sentenced to death in a trial that was rife with perjured testimony and manufactured evidence that Amnesty International found, “did not meet the minimum international standards for a fair trial.”

Mumia was working as a cab driver to make extra money when he happened upon Officer Faulkner, who had stopped his brother Billy Cook, and was beating him in the head with a metal flashlight. The prosecutor, Joseph McGill, presented a story that has Mumia running behind the officer and shooting him in the back. He then claimed that the officer turned around and pulled his weapon, shooting Mumia in the chest. McGill ends the story by saying the officer fell to the ground, where Mumia stood over him and unloaded on him, missing with

four shots but hitting him once between the eyes. McGill also claimed that Mumia confessed to the shooting later on in police custody.

None of the physical evidence supports the prosecution's case! Mumia did legally own a gun, not uncommon for anyone driving a cab in Philadelphia during that time. However, the police never tested his gun to see if it had been fired nor tested his hands to see if they had recently fired a gun. The bullet taken from Faulkner could not be matched to Mumia's gun.

There were no divots in the sidewalk around the officer's head, as there would have been if the shooter had stood above him. The only bullets that were found were approximately eight feet west of where Faulkner was laying and were from an angle that would not have been possible from the trajectory where Mumia entered the scene. The bullet wound that hit Mumia also debunks the prosecution's scenario. The bullet was traveling at a hard downward trajectory, suggesting that his body was leaning forward while still running to the scene when he was shot, and that the officer was elevated, likely standing on the sidewalk. The prosecution witnesses told different stories in their original statements than they did at trial. One, a prostitute named Cynthia White, changed her story five times by the time she reached trial. Another, a cab driver named Robert Chobert, who was driving with a suspended license while on probation for arson, first told arriving officers, "the shooter ran away." He then said the shooter ran thirty feet and fell, despite the fact that Mumia was laying less than three feet from Faulkner. Crime scene photographs that were never disclosed to the defense until 2007 show that Chobert was not parked where he said he was. They also confirm that there were no bullet divots around Faulkner's head, that police collected evidence incorrectly – damaging its integrity, and that the officer's hat had been moved from its original place on the roof of a car, suggesting that Faulkner was talking to a passenger. Four different witnesses claimed that they saw someone running from the scene..." For full article see:

“I’m Not Going to Give Up”: Leonard Peltier on Indigenous Rights, His Half-Century in Prison & Coming Home

“AMY GOODMAN: In a *Democracy Now!* global TV/radio broadcast exclusive, we spend the hour with longtime Indigenous activist Leonard Peltier. In February, he was released from a federal prison in Florida after spending nearly half a century behind bars for a crime he says he did not commit. President Biden, on his last day in office, commuted Peltier’s life sentence to home confinement. Biden’s decision came after mounting calls by tribal leaders and supporters around the world in a decadeslong community-led campaign fighting for his freedom.

In the '70s, Peltier was involved with AIM, the American Indian Movement. In 1975, two FBI agents and one young AIM activist were killed in a shootout on the Pine Ridge Reservation in South Dakota. Two AIM members were later arrested for killing the agents. At trial, the jury acquitted them. Leonard Peltier was arrested later, tried separately and convicted. Peltier has always maintained his innocence.

Notable supporters of Leonard Peltier over the years included Nelson Mandela, Pope Francis and Amnesty International. Supporters of Peltier say his trial was marked by gross FBI and federal prosecutorial misconduct, including the coercion of witnesses, fabricated testimony and suppressed exculpatory evidence.

After being released in February, Leonard Peltier returned home to live on the Turtle Mountain Band of Chippewa Reservation in Belcourt, North Dakota. September 12th was Leonard Peltier’s 81st birthday. People gathered throughout the day, visiting him to celebrate this first birthday in almost a half a century where he was home. We got there on his birthday. 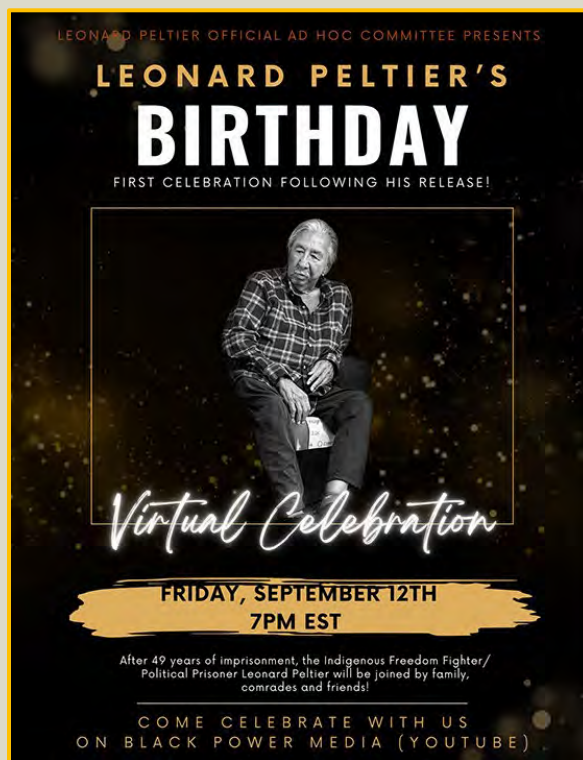

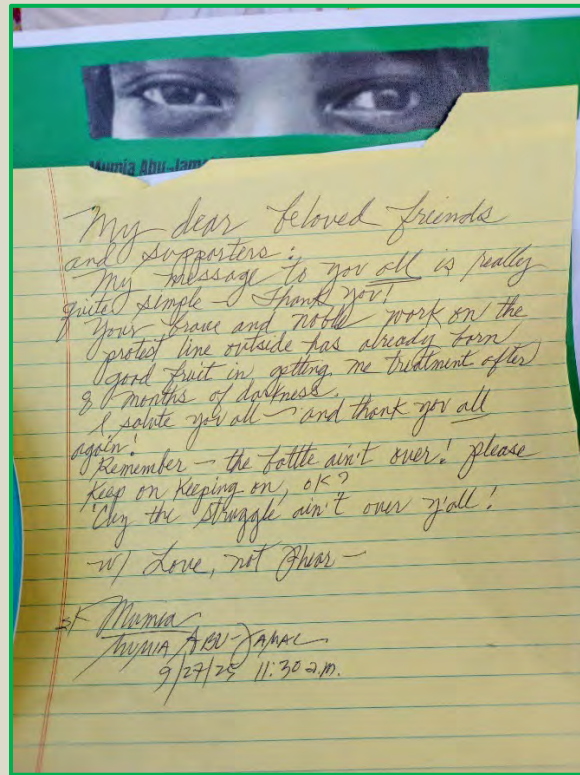

BLACK ALLIANCE FOR PEACE

"The Black Alliance for Peace (BAP) seeks to recapture and redevelop the historic anti-war, anti-imperialist, and pro-peace positions of the radical Black movement.

The Black radical perspective sees the relationship of Black people in the United States through a much different lens than the fictional accounts of U.S. origin myths. The stark reality of the barbaric Atlantic slave trade, Indigenous land theft and brutal genocidal policies occupy the center of that perspective. The strategy of colonialist war, as well as systematic state and private violence, is what we see as the heart of the methodology for establishing and then maintaining the first White supremacist republic in the history of human societies. Indeed, the establishment of the United States with the ratification of the constitution in 1789 in the midst of the turmoil in France and the beginnings of the French revolution is not seen from the radical Black perspective as the dawn of a new day for human liberation in either country, but the continuation and re-consolidation of what Rodrick Bush called the "Pan European Colonial Project," that vicious, hegemonic campaign that was fueled by the European invasion of the Americas in 1492.

Despite the high-sounding proclamations of liberalism and enlightenment thought that asserted the universal equality and inherit rights, systematic, extreme, unspeakable violence constituted the relationships between Europeans and the racialized "others." For the Africans who ended up in the United States, not one decade of peace has existed between African descendants and white authorities.

With the growing maturation of the radical Black movement in the late 19th and early 20th centuries, the formal institutionalization of racial apartheid in 1896 with Plessy v. Ferguson, the beginnings of the Pan African movement, the Russian revolution, and agitation and organizing in Black urban colonies like Harlem (that offered a precarious refuge for the first wave of escapees from the fascist totalitarian South), saw the creation of a solidarity movement among Black people in opposition to U.S. and European colonial violence.

From the opposition to fascism in Spain and the invasion and occupation of Ethiopia by Italy in the 1930s through the 1960s when leading black organizations like the Student Nonviolent Coordinating Committee (SNCC) sparked the anti-Vietnam War movement with their opposition to the war and their expression of solidarity with the Palestinian national struggle, Black anti-war and anti-imperialist positions reflected the Black internationalist stance at the center of the Black radical tradition.

In general, suspiciousness and skepticism—if not outright opposition—to U.S. militarism characterized much of the Black community's views regarding U.S. foreign war policy until the ascendancy of the first Black president, Barack Obama. During the Obama administration, a significant shift took place in the consciousness of large segments of the African American population. They became more supportive and uncritical on U.S. militarism and interventions. Many seem to be unaware or had forgotten Dr. King's sharp denunciation of U.S. militarism

and violence, and the historical opposition to U.S. imperialism that characterized much of the positions of the Congressional Black Caucus—pre-Obama.

Militarized policing, over \$4 billion worth of military hardware turned over to local police departments, extrajudicial murders (police executions), the school-to-prison pipeline, aggressive military recruitment of black and Latino youth, the normalization of militarism, and general popular support for the militarized strategy of U.S. global “Full Spectrum Dominance” provides the context for and impels the establishment of a Black Alliance for Peace.

The establishment of Black Alliance for Peace will be a first step in revitalizing the critical, moral stance on issues of war and state repression the Black population in the United States had historically embraced. BAP is part of the effort to rebuild the broader anti-war, anti-imperialist and peace movement.

By comprehensively linking the issue of state violence and militarism, BAP will concentrate its efforts on not only opposing the U.S. war agenda globally but the war and repression being waged on Black and Brown communities domestically.” <https://www.thejerichomovement.com/partners/black-alliance-peace>

Palestinian and Global Civil Society Call for a Global Day of Action and Strike September 18th, 2025



"On September 18, 2024, the United Nations General Assembly (UNGA) adopted [Resolution A/ES-10/L.31](#), demanding Israel end its unlawful presence in the Occupied Palestinian Territory (OPT) within 12 months and to immediately comply with the provisional measures in the genocide case at the International Court of Justice (ICJ). Since then Israel has entrenched its occupation and escalated its genocidal attacks on Gaza causing the United Nations to declare famine in Gaza. The Palestinian NGO Network (PNGO) and Global Civil Society is calling for a

Global Strike and Day of Action on September 18, 2025, to denounce Israel's refusal to comply with this order, and to demand that UN member nations act immediately to end Israel's genocide against the Palestinian people. The member nations of the UNGA have the power and obligation to stop the genocide, given that the Security Council has repeatedly failed to do so because of the US veto.^[1] Using mechanisms available to them, in particular the [Uniting for Peace](#) Resolution and non-recognition of Israel's credentials, the state members of the General Assembly could act immediately to end the genocide within a month. PNGO and the global organizations joining this call endorse a Uniting for Peace resolution that specifically includes the actions laid out in a [recent article](#), including that it mandate a multinational, UN protection force to deploy to Gaza and the West Bank, acting at the request of the State of Palestine, to protect civilians, open entry points via land and sea, facilitate humanitarian aid, preserve evidence of Israeli crimes, and assist in recovery and reconstruction..."

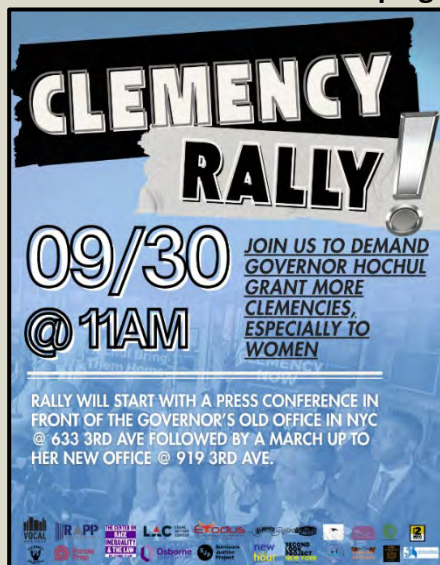

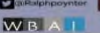

Raíces: An exclusive talk with journalist Jean Guerrero Sept 11

"International and U.S. Based Organizations Call for Resignation of Annalena Baerbock from Role as President of UN General Assembly New York, NY — On 9 September 2025, former German Foreign Minister Annalena Baerbock assumed her functions as President of the United Nations General Assembly (UNGA).

The International Association of Democratic Lawyers, Progressive International and CODEPINK are hosting a press conference and rally outside the German Consulate in New York City on 11 September at 12:00 — to highlight imperialism's continued efforts to erode international institutions, to bring attention to Baerbock's crimes, and to demand her resignation from the post.

With a record of promoting militarisation, blocking ceasefire efforts and undermining international diplomacy and justice, Baerbock's values are fundamentally at odds with the mission of the United Nations. That is why we are now escalating the campaign against her presidency. Baerbock led the call to remilitarize Germany and pull

Europe into armed interventions abroad. Baerbock justified attacks on civilians under the guise of "self-defense". Baerbock blocked ceasefire efforts as Israel devastated Gaza and opposed peaceful solutions to the war in Ukraine. Baerbock repeatedly undermined efforts to build dialogue with other countries, attacking their leaders as "dictators". Baerbock refused to enforce arrest warrants for Israeli officials implicated in crimes against humanity. Baerbock attacked South Africa's ICJ case against Israel, rejecting it as "baseless" despite the

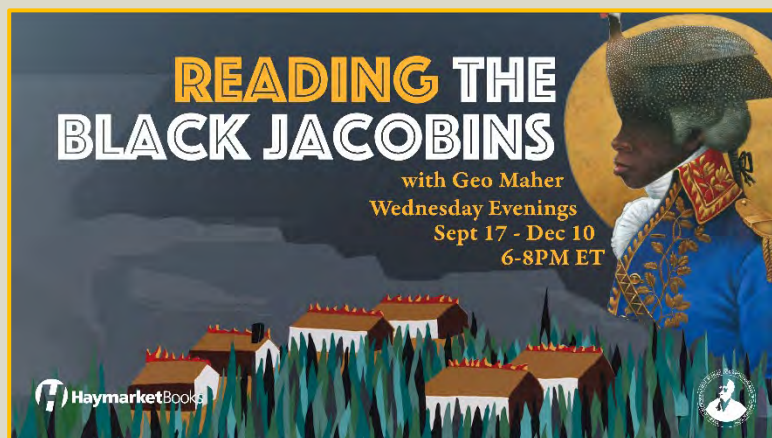

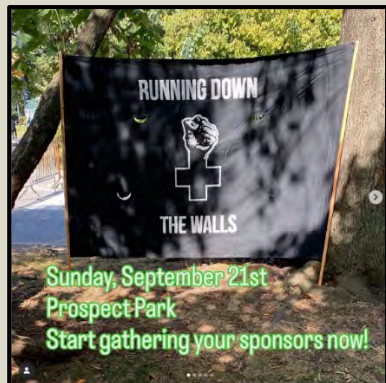

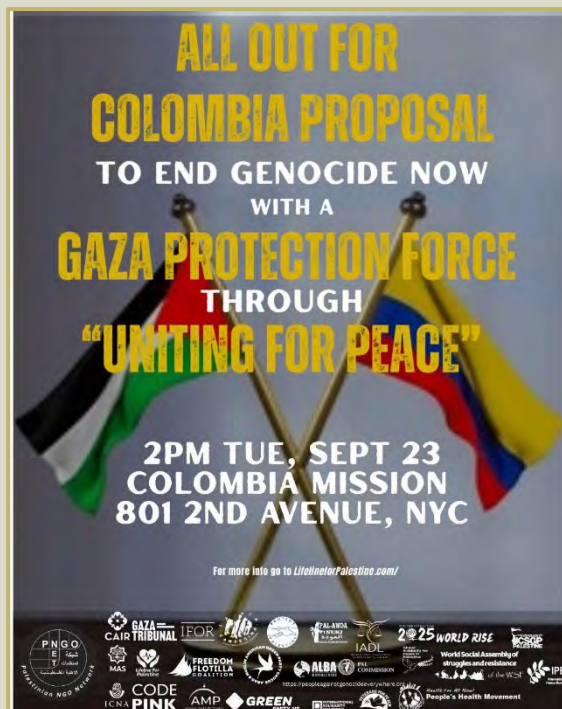

"Join MECA as we welcome **Angela Davis, Ali Abunimah, and Lara Kiswani** in conversation on the legacy of Malcolm X, the history of Black-Palestinian solidarity, and the ongoing genocide in Gaza.

Malcolm X's views on Palestine were shaped by his evolving global perspective and his firsthand experiences during his travels. In 1964, he embarked on an extensive tour of the Middle East and Africa. During a visit to the Gaza Strip, he witnessed the conditions in Palestinian refugee camps and met with displaced individuals, an experience that deeply impacted him. He came to view the Palestinian struggle as an integral part of a wider global fight against colonialism and imperialism. He articulated these views in his article, "**Zionist Logic**," published in the *Egyptian Gazette*, where he critiqued the establishment of Israel as a form of settler colonialism and challenged its historical and religious justifications. He drew a direct parallel between the displacement of Palestinians and the oppression of Black people in America, emphasizing that both were part of a universal struggle for justice and self-determination against a system he saw as a new form of colonialism.

Angela Y. Davis, Professor Emerita at UC, Santa Cruz, is an activist, writer, and lecturer. Her work focuses on prisons, police, abolition, and the related intersections of race, gender, and class.

Ali Abunimah is executive director of The Electronic Intifada. He is the author of *One Country* and *The Battle for Justice in Palestine*.

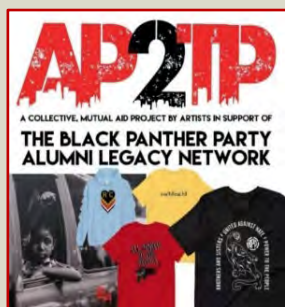

of five accounts of genocide against Black, Brown, and Indigenous people??

Dear Friend and Fellow Freedom Fighter,

The Spirit of Mandela Coalition, following up on the October 2021 International Tribunal verdict finding the US Guilty of Genocide against Black, Brown, and Indigenous people (see full verdict [HERE](#)), is calling for the building of a new mass grassroots formation: The Peoples' Senate. The people need to govern and represent themselves in combating genocide and addressing their right to a just and humane existence. Our vision is for the Peoples' Senate, organized directly by our oppressed communities, to grow into a body which will serve that purpose.

Today our communities face the most egregious violations of our human rights since the civil rights and Black power movements of the 1960s and '70s. Conditions we are living under include random mass shootings, right-wing vigilante attacks, police violence and murder, environmental racism, the reassertion of "states rights" (the "right" of states to ignore basic human rights), and healthcare racism. The US government dangerously scapegoats immigrants; causes destabilization, extreme violence, bombing, and killing of Black, Brown, Indigenous, and poor people all over the globe – and spends billions of dollars to do it; and keeps hundreds of thousands of people living in homelessness and poverty in the US. Our communities are facing targeted attacks against voting rights, workers' rights, women's rights, and Indigenous Peoples' rights as right-wing elected officials and appointed judges roll back decades of hard-won battles for justice. While out-voting right-wing candidates during elections is important, voting alone will not be enough. We must organize to put more pressure on the system for major change.

The US Congress and Senate are representatives of the rich and powerful. They refuse to address the necessity for universal healthcare or a sound nationwide infrastructure providing access to clean water and other necessities. Corporations ignore and violate the needs of the planet while evading their fair share of taxes. US prisons are filled with Black, Brown, Indigenous, and poor people, many incarcerated for crimes they did not commit and/or serving sentences that far outweigh whatever criminal acts they may have committed. The oppressed national communities of Black, Brown, and Indigenous peoples all have political prisoners and prisoners of war incarcerated since the 1960s until today, who have fought for our liberation and are being held in prison unjustly or only released when near death. We want them all freed now!

Building our own Peoples' Senate will enable us to organize locally from a position of strength and connect local activists with others, in other parts of the country, who may be pursuing similar goals while electing "Senators" who are mandated to represent our interests and demands. A Peoples' Senate can fight for changes that protect and ensure our right to vote, our right to control our own bodies, our right to live free from discrimination as LGBTQ+ people, our rights to living wages and safe working conditions, our rights to sovereignty and dignity, and our rights to live free from state violence and abuse.
